Our priorities are safety, healthiness and happiness.
















The RSE Code sets out each strand of teaching and learning in three broad developmental phases.

The mandatory RSE Code supports schools to design their own RSE. These strands allow practitioners to design and develop a curriculum, which is developmentally appropriate for specific learners. Pupils will be involved in designing the curriculum so that it addresses their needs and the issues that they identify.

Relationships and Sexuality Education will be introduced to the pupils through:

- Circle time activities
- Story books
- Curriculum subjects
- Personal and Social Education programmes
- Partner organisations
- Informally as opportunities, arise in the classroom.

Topics will cover:

- Relationships, identity and rights of the individual.
- Reproduction, the human body, health issues and well being.
- Learners rights to safety and freedom from discrimination.
- How and where to seek help, information and support.

Learning Outcomes for Phase 2: From age 7.

- Have the ability to form and maintain relationships, which are equitable, respectful and kind.
- To understand how to be a good friend and advocate for others.
- Recognise the characteristics of different families.
- Value and recognise the importance of gender equality.
- Have an understanding fertility and the processes of reproduction.
- Have the knowledge and skills needed to manage personal self-care and hygiene.
- Have an understanding of the right for everyone to be free from harm.
- Have an awareness of the benefits and dangers of the internet and social media in forming friendships online.

Learning Outcomes for Phase 3: From age 11.

- Have an understanding of the the positive and negative characteristics of a range of relationships.
- To recognise the importance of equity, and mutual respect.
- Have an understanding about the diversity of relationships.
- Understand and respect all people in relation to sex, gender and sexuality.
- To understand fertility, sexual function and menstrual health and how to find information and support when needed.
- To understand how hormones affect emotional and physical health.
- Critically engage with positive and negative representations of a diversity of bodies.
- Understand the importance of inclusivity.
- Developing a sense of individual and social responsibility to others.
- Recognising harmful, behaviour in personal relationships.
- Understand how to advocate for safe environments and the rights and understanding of everyone on a range of RSE issues.
